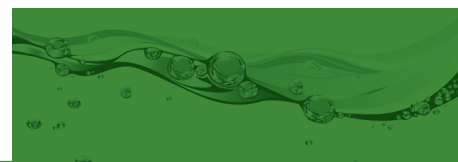

Solopol® classic is proven to have very good skin compatibility properties in human-experimental tests and in practical use.

Shelf Life

Solopol® classic can be stored in a closed container at room temperature for up to 30 months.

All STOKO® products are tested for stability at temperatures between 23°F and 104°F. When tested at temperatures below 41°F and above 86°F, the products begin to fluctuate in viscosity.

Hand cleaners may become cloudy or freeze partially at temperatures of 32°F or below. However, they are usable after thawing.

First Aid
